**Winter registration begins

All children must meet age eligibility requirements and be a county resident, or attend school in Dare County. The age cutoff date is January 1, 2018. The child must be the required age listed for that activity on January 1, 2018. NO EXCEPTIONS.

The registration form AND photo release/code of conduct form MUST be completed for each child at the time of registration.

BASKETBALL



Start Smart Basketball

Ages: 3 and 4 Co-ed **with parent/guardian**

When: Every Thursday Feb. 15-March 15, 2018 5:30-6:15 pm

Cost: \$40

Start Smart Basketball prepares children for organized basketball. Skills taught will include dribbling, passing, shooting and basic game rules. All participants will receive 1- mini basketball, 1-soft Teslon basketball, 4 cones, a jersey and participant manual. Registration deadline is Feb. 5. Maximum of 12 participants. All children must be potty trained.

Beginner Basketball

Ages: 5 and 6 Co-ed

When: Teams will be assigned and start play in January.

Cost: \$35

Age cut off is January 1, 2018, NO EXCEPTIONS.

There is no skills day in this age group.

Boys and Girls Basketball

Ages: 7—12 Co-ed

When: Teams practice in December (not during school break)— games start in January

Cost: \$35

Age cut off is January 1, 2018, NO EXCEPTIONS. Teams will be split into girls league, and boys league, ages 7-9 and 10-12.

Skills days will be in the Fessenden gym. Teams will be selected and coaches will notify players of their practice schedules.

MAXIMUM 15 CHILDREN

Adult only class:

Who: Co-ed age 18 and over

Cost: \$60

When: Every Monday and Friday 7:30-8:30 pm

This is an adult only class. No children will be permitted to accompany the participant, or wait in the building.

These classes are taught by Trafford Hill. At the end of the session, there will be testing for belts. However, if the participant does not have required attendance as determined by the instructor, they will not be eligible to test.
