Registration begins Monday, July 8, ending Friday, August 30.  
at 5:00 PM.

All children must meet age eligibility requirements, and be a county resident, or attend school in Dare County. The age cutoff date is September 1, 2019, meaning the child must be the required age for the activity on September 1, 2019. NO EXCEPTIONS.

The registration form AND photo release/code of conduct form MUST be completed for each child. Children must be potty trained, no pull ups allowed.

Anyone coaching or otherwise volunteering with a program will be required to attend a coaches training clinic, and submit to a background check.

Registrations can be taken at the Fessenden Center Monday—Friday, 8:30-5:00 pm.

# GYMNASTICS

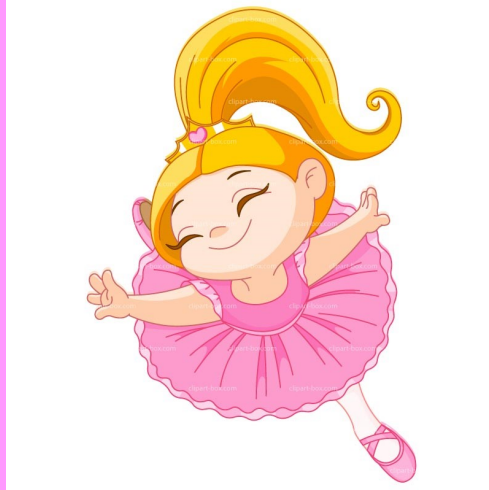
Ages: 3-14 Co-ed Maximum 80 participants

Exceptions include medical reasons, participant moves out of the area, or if the department cancels or reschedules a program. A \$10 processing fee will be subtracted from the refund amount. All requests for refunds must be submitted *in writing* before the start of that activity/program.
